The total amount of this contract is _____ due and payable immediately at the time equipment is put into storage. Amount due will be taken from the front of the hitch to the end of the bumper measurements.

Any equipment that might be taken in or out during the storage period requiring the assistance of the caretaker shall be at a charge of **\$10.00** each occasion and must be paid by check payable to the Paulding County Agricultural Society.

NOTICE: There will be a **\$25.00** charge **PER DAY** for anything not picked up on March 20, 2027, unless prior arrangements have been made. No space is to be sublet to another party. _____ initials.

INSURANCE: The Lessee, at his/her own cost and expense, shall obtain Commercial Liability Insurance covering their operations and activities, which are subject to the agreement. Such liability insurance shall cover both bodily injury and property damage liability and shall provide a limit of coverage not less than \$500.00 per occurrence. The Lessee shall attach to this contract a certificate of insurance verifying the existence of the above insurance. **FAILURE ON YOUR PART TO ATTACH EVIDENCE OF A CURRENT AND VALID INSURANCE POLICY WILL PRECLUDE YOU FROM PARTICIPATION IN THIS EVENT.**

INDEMNITY: The Lessee assumes liability for and shall indemnify, protect, save and keep harmless the Lessor, its agents and servants from and against all losses, damages, penalties, claims, actions, suits, costs, expenses, and disbursements, including legal expenses of whatever kind and nature imposed upon, incurred by, or asserted against the Lessor in any way relating to or arising out of this lease or the use of equipment. The indemnities contained in this section shall continue in full force and effect, notwithstanding the termination of the lease. LESSOR IS NOT RESPONSIBLE FOR DAMAGE TO FIXTURES MOUNTED ON VEHICLES, SUCH AS A/C UNIT, SKYLIGHTS, ANTENNAS, ETC.
